Teamwork

The Health Department is composed of many divisions, including Administrative, Environmental, Fiscal, Nursing, and Preparedness. While each division has different responsibilities, they work together to meet our mission to serve and educate the citizens of Hocking County with public health programs that prevent disease, promote healthy lifestyles and protect the environment.

Environmental Health

Programs

In 2023, the plumbing program spent approximately 334 hours conducting inspections, driving 6,401 miles. The sewage and new building programs totaled 1,082 hours of fieldwork, spanning 7,413 miles. The private water program encumbered approximately 225 hours of inspections and sample collections encompassing 2,821 miles. The food safety program encumbered 447 hours of inspections, spanning 2,338 miles. Recreation campground and pool program inspections totaled 133 hours, driving 997 miles.

Campground Program

The Ohio Department of Health conducted a survey to determine if we are carrying out the mandated program requirements as set forth in the Ohio Revised and Administrative Codes for our Campground Program. Due to excellent work by the Environmental Staff and Clerk Nichole Sigler, HCHD was removed from provisional status and is now a licensor for Campgrounds.

Mosquito Control Grant

We hired 2 interns for our summer mosquito program. Mosquitoes were collected then sent to the Ohio Department of Health for testing and identification. The interns also conducted pesticide resistance testing to determine if any mosquitoes had become resistant to pesticides. We will apply again for 2024 for this grant from the EPA to continue collecting and testing mosquitoes, to larvicide to control mosquito populations, and to help educate our residents and visitors on how to prevent mosquito-borne diseases and to expand our tick collection and population monitoring.

Contractors Workshop

We hosted our annual contractor's workshop, where 88 contractors and 6 different vendors participated. This workshop is held annually so sewage treatment system contractors can obtain their required 6 hours of continuing education.

Sewage Grant

We continue to administer the Water Pollution Control Loan Fund (WPCLF) from the Ohio EPA to assist homeowners in repairing or replacing their failed sewage treatment systems (STS). Since 2010, we have helped 250 homeowners and received \$1,876,049.43 through the WPCLF program, making Hocking County a healthier place to live.

Lead

Throughout 2023 the number of cases of lead poisoning in our communities' children has increased. With this increase, the Hocking County Health Department is reaching out to do its part in educating about lead-based hazards. The health department aims to increase knowledge of lead and lead concerns and looks forward to adding lead education to community outreach programs.

We plan to provide reminders of the importance of testing all children between the ages of 1-5 years old for lead poisoning, which includes ongoing testing if warranted, and explain lead abatement and lead abatement funding opportunities to community members. We have been working diligently with the state of Ohio and have obtained a professional-grade HEPA vacuum to loan out to assist the residents of Hocking County.

Tobacco Use, Cessation, and Prevention

The Hocking County Health Department's tobacco prevention program continues to expand cessation services in Hocking County. Our mission is to decrease the burden of tobacco use for Hocking County citizens through tobacco prevention and cessation programs, disease prevention education, promotion of a healthy lifestyle, and protection of the environment. The Hocking County Health Department now has two certified tobacco treatment counselors to help Hocking County residents with their quit journey.

- Counseling can tell you how to avoid the things that make you want to smoke.
- Counseling and medication, when used together, can more than double the chances of quitting.
- Counselors at the Hocking County Health Department know how to help you be successful in quitting.
- Your first appointment will take place in person, and after that can be over the phone or in person.
- There is no out-of-pocket cost for counseling services.

Emergency Preparedness

Grant Funding

Through federal funding made available to the health department, our Emergency Preparedness Division continues to plan for emergency situations, drill, and exercise response plans, and review and update the plans annually with our local and regional response partners. In addition, each year, the Center for Disease Control and Prevention (CDC) requests preparedness activities be completed in exchange for that funding. In 2023, our activities included:

- A four-day Statewide Full-Scale Exercise focusing on the request, receipt, movement, storage, and preparation for dispensing of medications from the Strategic National Stockpile (federally managed medication, medical equipment, and supply stockpile);
- Annual review and update of our training plan to extend to 2028 (Multi-year Training and Exercise Plan);
- A focus on incorporating Cultural and Linguistically Appropriate Services into our plans and response;
- Multiple trainings for our Emergency Preparedness staff sponsored by the National Disaster Preparedness Consortium;
- Exploration and utilization of the Federal Emergency Management Agency's (FEMA) new Resilience Analysis and Planning Tool (RAPT); and
- Evaluation of our Medical Countermeasure (Dispensing) Program using CDC's tool.

2023 Community Health Needs Assessment

Rural Health Innovations, a subsidiary of the National Rural Health Resource Center, conducted a CHNA this year, in collaboration with Hocking Valley Community Hospital and the Hocking Valley Steering Committee, which included four members from the Hocking County Health Department.

A Community Health Needs Assessment (CHNA) serves multiple purposes. They are an opportunity for a hospital or public health department to connect with community members and partner organizations to discover how they rate the health of their community and to understand what they identify as their region's key health issues and opportunities. CHNAs are also an opportunity to advance health equity by identifying existing health inequities and working in collaboration to remove obstacles to health and well-being. After a discovery phase, the CHNA process is an opportunity to work with community partners to design strategies and actions to address the prioritized health needs of the community to improve well-being.

Report findings may be used for:

- Developing and implementing plans to address key issues as required by the Patient Protection and Affordable Care Act \$9007 for 501(c)3 charitable hospitals
- Promoting collaboration and partnerships within the community or region
- · Supporting community-based strategic planning
- Writing grants to support the community's engagement with local health care services
- Educating groups about emerging issues and community priorities
- Supporting community advocacy or policy development
- Supporting creation of a CHA and CHIP for public health


